OFFICIAL RULES

BY ENTERING THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES ENTITIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

**1. SWEEPSTAKES PERIOD:** May Weekly Who Knew Daily Trivia Sweepstakes (the “Sweepstakes”) begins on 5/9/2018 at 12:00 AM Central Time (“CT”) and ends on 6/8/2018 at 11:59 PM CT (the “Sweepstakes Period”). Sponsor’s computer is the official clock for the Sweepstakes.

**2. ELIGIBILITY:** Employees of Sponsor) and its affiliates, subsidiaries, divisions, fulfillment and advertising and promotion agencies (“Sweepstakes Entities”) and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and those living in the same household of each such employee, whether or not related, are not eligible to enter or win. **4. PRIZES, PRIZE DRAWING, AND ODDS OF WINNING:**

PRIZE DRAWING: Prize Drawing will be conducted by Sponsor. There will be a total of three (5) individual random Prize Drawings from all eligible entries. Prize Drawings will be conducted weekly each Friday of May 2018 Odds of winning depend on number of eligible entries received. Non-winning entries will not carry forward to or be included in subsequent sweepstakes or prize drawings of Sponsor.
